Each panel of Everlast Board & Batten has an integrated installation line guide to ensure the panel is fully seated within the interlock. Everlast siding is less than half the weight of fiber cement. Moving and lifting bundles of Everlast siding is easy – it is a one-person job, not two. Use your own standard carpentry tools! Unlike fiber cement and other products, no expensive blades or proprietary tools are needed. Everlast siding is lightweight and durable which vastly reduces the potential for breakage. In contrast, due to its heavy and brittle nature, fiber cement siding is easily damaged in transit and during installation causing high scrap rates. All this saves you on product and labor costs.

Unlike fiber cement, when cut, Everlast siding produces no harmful dust that can cause serious health issues like other products that can cause silica health hazards. Reduce costs for PPE (personal protective equipment) or potential future health issues. Installing Everlast siding eliminates OSHA-mandated respirators, protective clothing, and dust collectors that are required with fiber cement.
